General Rules - APA 7th Edition Citation Examples ...

For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005). For direct quotations, include the page number as well, for example: (Field, 2005, p. 14).

In-text Citation - APA Quick Citation Guide - Library ...

What is the APA Citation Style? The APA citation style is a parenthetical author-date style, meaning that you need to put the author's last name and the publishing date into parentheses wherever another source is used in the narrative. The APA format consists of in-text citations and a reference list, along with guidelines for formatting the paper itself.

If you are paraphrasing or summarizing information from a source, APA only requires you to cite the author's last name and year of publication in your in-text citation. For example: Some educational theorists suggest that schooling and a focus on teaching literacy divided society into educated and uneducated classes (Cook-Gumperz, 1986).

Basic book citation format The APA in-text citation for a book includes the author's last name, the year, and (if relevant) a page number. In the reference list, start with the author's last name and initials, followed by the year. The book title is written in sentence case (only capitalize the first word and any proper nouns).

How to Cite a Book in APA Style | Formats & Examples

Note the page number where the quote or information appears in the paper. Write "p." for page number and place a dash between the numbers if the quote or information you are citing spans more than 1 page. For example, you may write, "There are several factors to consider about lobsters' (Gardner, 2008, p. 199).".
